## Village Council News

Rescheduled from July 5, the July 12 Village Council meeting quickly waded through the approval of minutes and financial reports to get to key issues. Greg McCarry introduced Shari Hagey who has been promoted to Project Administrator and will be the liaison between PLVC and Port Ludlow Associates. Greg then said the sale had stalled over a State Aquatic Lands lease necessary for transfer of the Marina that was the last issue to be resolved. He said all signatures were in place and the buyer's funds in escrow. Transfer was still expected to take place in July.

### County News

Jefferson County Commissioner Dan Titterness and Port of Port Townsend Commissioner Conrad Pirner provided updates. Dan stated that sales tax revenue and building permit applications were down. Sales tax is second only to property tax as income to the County. He cited efforts being used by the Economic Development Council (EDC) to retain current businesses and recruit new businesses to the County. With the streamlining of internal operations and increasing business tax revenues, he hopes to offset much of the lost sales tax revenues. Dan also mentioned that individuals can join the EDC and that more input from the Port Ludlow community (by way of volunteers) would be helpful. There is currently a position open. A survey of County residents was included in the "Leader" for anyone wishing to express their thoughts. Conrad informed Council members and residents that their insurance has quadrupled since the earthquake. In the good news column, the Coast Guard will station a second cutter in Port Townsend and has leased a slip. When the Port Hudson property returns to Port control, income from that property will increase. The expiring lease did not take into account the fair market rate for rental. Changes will be made slowly, with most of the first year's efforts spent on maintenance issues. Sally Smith interjected that Conrad was up for reelection this fall and urged a good voter turnout.

Fire Chief Wayne Kier told the Council that construction on the new firehouse had been delayed for five weeks

due to water and sewer hookup permit problems. He also requested volunteer assistance in preparing a landscape plan for the new building. Anyone interested in assisting should give him a call. A major issue of concern for our District is the Emergency Medical Services (EMS) levy that is on the **Tuesday, September 18** ballot. This levy is not a new request for funds, but a continuation of the current levy. Without passage of the levy, services would be severely cut. Passage requires 645 "yes" votes. Since our last election was a presidential election, voter turnout was high. To achieve the number of votes needed based on last year's count of 2,685; a minimum of 1,074 votes must be cast with at least 645 voting yes so everyone's vote is very important. Chief Kier also thanked the District for extending his contract until 2004. Gene Carmody displayed a memorial paver that will be used as a fund-raising project for the new fire station. The granite pavers will be used for the walk to the front of the station. Pavers are \$50 each and purchase forms are available at the Friday Market, Bay Club, and Beach Club.



### Committee Reports

## Aren't We Lucky!

All of us who own property in Port Ludlow are contributing about \$50 a year each to a \$8,589,992 operation which takes our tax money, returns nothing to us, and can't keep its financial records straight. This operation is called the Public Utility District No. 1 of Jefferson County (PUD). You will find their offices in the old post office building in Port Hadlock.

The Jefferson PUD has been around since November 1940. It has collected taxes from this area all that time and apparently never had a project in the Port Ludlow area. The Ludlow Maintenance Commission (LMC) is asking the Jefferson County commissioners to activate a County Boundary Review Board as provided by state law to determine if the LMC area of Port Ludlow may be removed from the PUD.

The LMC was partly concerned about the additional costs of operating the newly formed Port Ludlow North Bay Drainage District. The LMC says the Drainage District "would better utilize tax funds now contributed to the PUD." The Drainage District is now in the process of establishing a system for determining assessment values in North Bay.

Now, what does the PUD do? It operates a number of small water districts, serving 907 customers and eight sewer districts with 67 septic connections. Their operating budget is \$945,676, about a third of which goes to wages. The major liabilities of the PUD are five bonds totaling \$1,792,898 issued to cover costs of five PUD sub-districts.

In a letter March 1, 2001, to James G. Parker, manager of the district, David A. Papandrew, CPA, an auditor from Sequim, says the PUD fails to meet generally accepted accounting principles. The PUD hired the accountant for its annual review. He says the PUD "has elected to omit substantially all the disclosures and statements of cash flows." The Washington legislature says review boards are needed "to provide a method guiding and controlling growth." While Jefferson County is not populated enough to have review boards appointed automatically, the County Commissioners may create and establish such a board. That is what the LMC has asked be done.

In the late 1990s, Ted Shoulberg, then a member of the Port Townsend City Council made an effort to have Port

Townsend relieved from PUD taxes for the same reason the LMC is now requesting relief: taxes paid but no return. State officials dodged a direct answer to Shoulberg; but Brian Sonntag, State Auditor, did declare that the city taxes could not be "used to subsidize the PUD's utility operations." He added, "His office couldn't figure out how the PUD used its tax money because of the inability of their accounting system to produce an accurate accounting of the expending of the taxes received."

Sounds like a job for the Jefferson County Prosecutor. After all it is our taxes they apparently misspent, but where and how?

## Are You Speeding?

The established speed limits are the result of a review and recommendations from the community in 1997 for consistency throughout the Port Ludlow Master Planned Resort. The Port Ludlow Village Council recently endorsed the continuation of the speed limits as posted and requests that community drivers respect them.

## Tai Chi Classes

If you have been around the Beach Club on Monday mornings, you may have seen a group of enthusiastic Port Ludlow residents learning the slow graceful movements of Tai Chi Chuan, an ancient Chinese art of exercise. “We have had an excellent turnout for this class,” says instructor Stephanie Morrell of the Gilman Tai Chi Studio. “I think more and more people are seeing Tai Chi on TV or have been reading that Western medical research is showing Tai Chi prevents falls, lowers blood pressure, improves circulation, helps arthritis, enhances concentration. Some people have come out of curiosity, others to rehabilitate an injury, and even a few to improve their golf game!”

Tai Chi Chuan can be learned by people of all ages. Originally a secretive martial art, its roots going back hundreds of years in China, Tai Chi is now practiced by people world wide to enhance over-all health. While Tai Chi strengthens internal organs, bones, body structure and balance, one of the important principles is that learning to move harmoniously is more than physical exercise—it also involves training the mind to be calm and quietly focused. After a while, the Tai Chi practitioner begins to cultivate a sense of harmony that extends beyond the physical body into other daily pursuits.

The classes begin slowly with warm-up exercises designed to relax the muscles and open the joints. Basic principles and stances are taught along with a Yang-style short form and simple breathing and meditative practices. A new beginning class starts **Monday, September 10** at 10:00 a.m. at the Beach Club. All Port Ludlow residents are welcome.

### Did You Know?

- Your firefighters from District No. 3 put their training and experience to the test by rescuing a small boy from a local abandoned water well.
- Sixty-five percent of all Fire District No. 3 emergency personnel are trained at the Emergency Medical Technician (EMT) level or higher.
- Fire District No. 3 fire engines are licensed aid vehicles equipped with automatic defibrillator and first aid equipment.
- Fire District No. 3 has a mutual aid agreement with the Poulsbo Fire Department and North Kitsap Fire and Rescue for advanced life support response as a backup into Port Ludlow.

## Make Yourself Heard

Jefferson County is developing a nonmotorized transportation plan and updating the parks and recreation plan. These plans will guide the provision of nonmotorized transportation, parks, and recreation facilities throughout the County. Nonmotorized transportation facilities include designated bicycle routes, safe walking routes for school children, and sidewalks and trails for pedestrians. The plans are an important part of the County's effort to enhance the quality of life of all its citizens. Having adopted plans is necessary to obtain state funds, including grants, for projects.

Jefferson County Public Works Department is hosting a series of forums to provide opportunities for the public to participate in developing the plans. At the first series of forums held last April, Public Works presented information on the existing nonmotorized transportation, parks, and recreational facilities. The Department also conducted a visioning exercise with participants.

The Department will host a second series of forums in Port Ludlow, Port Hadlock, Port Townsend, and Brinnon during the week of **August 13**. The forums will consider goals and strategies for providing additional facilities. ## Commissioners Conduct Public Hearing on Drainage

The Board of County Commissioners (BOCC) took testimony during a public hearing on the Drainage District Assessment System. There were approximately sixty people in attendance; most of the persons testifying were in opposition to the method of assessment. The owners of the five-acre parcels in Port Ludlow were concerned that they were being assessed at a rate that was unreasonable. They argued their assessment is about five times as much as a smaller parcel, yet both are limited to one dwelling. They also argued that the location of their property was such that it did not have a drainage problem and did not contribute to the overall problem within the District.

The method of assessment recommended by the Drainage District Commissioners to the BOCC was a system that took the acreage within the District and created an assessment factor that represented 35 percent of the assessment per acre. Each parcel would be assessed on its proportion of the total area of the District.

In the event that a dwelling was on that parcel, a factor that represented 65% of the total impervious surface of the District was added to the area charge. Each occupied parcel would be assessed on the proportion of the total and its proportion of the total impervious surface. Some considerations that could have been used would be matters in mitigation and aggravation and a method of increasing the assessment for those who gained the most benefit or caused the most problem. This adjustment would probably require zones to be created. Some of the disagreement with the system was based on these factors not being considered. Other protests were based on existing surface water systems that have already been installed and paid for by the owner. Future assessments would likely take these matters into consideration. At present the Drainage Commissioners are only concerned with an operating budget since an engineering study and recommended improvements are not yet available.

Members of the audience spoke to all the above points. Greg McCarry, representing the Developer, submitted written testimony. He also spoke to the inequity of excluding some reserve acreage while not excluding all of the land not yet built on. Throughout the testimony it became abundantly clear that the entire audience supported the Drainage District but did not necessarily support the

method of assessment first suggested. Almost everyone who addressed the Commissioners praised the efforts of the Drainage District Commissioners and agreed that storm water control was and is a community issue. The consultants hired by the County did not fare as well and did receive comments to the effect that more thought should have gone into their recommendation. To their credit they did submit revised methods of assessment for consideration by the Board of County Commissioners.

Bert Loomis spoke to the BOCC regarding the amount of money he has spent developing his on-site system and the fact that no consideration was given to that effort. Speaking of the Consultants he said, "They didn't do their homework."

The Drainage Commissioners were able to report that they had just received word that a five-year loan has been approved for \$80,000. This will spread the cost of the District out and make it easier to fund this first budget.

Commissioner Walt Cairns, responding to a resident of Plot 7, said he personally agreed they should not be required to pay an assessment to their homeowners' association and the District, and he felt that the District should take over maintenance of their drainage facility. Joe Darcy rose and said he is ready to quitclaim the facility to the District right now.

During testimony the Commissioners were asked to consider the matter of mitigation and aggravation, as well as zones based on those who received the most benefit, and those who created the most problem. They were also asked to establish an appeals process. The Commissioners were told that they had the authority to reestablish the assessment process (with public hearings) at any time it was appropriate.

Some considerations that could have been used would be matters in mitigation and aggravation and a method of increasing the assessment for those who gained the most benefit or caused the most problem. This adjustment would probably require zones to be created. Some of the disagreement with the system was based on these factors not being considered. Other protests were based on existing surface water systems that have already been installed and paid for by the owner. Future assessments would likely take these matters into consideration. At present the Drainage Commissioners are only concerned with an operating budget since an engineering study and a list of recommended improvements are not yet available.

## Annual Hydrant Flushing Program

Olympic Water and Sewer will be conducting hydrant flushing for the entire Port Ludlow area beginning the week of **August 6**, and lasting until approximately **August 24**. The crews will flush hydrants between the hours of 8:00 a.m. and 3:00 p.m.

This program, designed to flush away traces of minerals left behind by the water, may cause a harmless and temporary change in the appearance of the water. The lines need to be flushed periodically to prevent buildup and to prevent problems to the system.

Changes to the water are generally in color and the brownish water can be eliminated by running your tap a few minutes. It is a temporary condition and the water will quickly return to normal.

## Beach Club Swimming Lessons Save a Life

Early this month Evan Gabriel, 8, of Werner Road in Swansonville found himself very grateful for the swimming lessons he has been taking at Port Ludlow's Beach Club. Evan was playing outside of his aunt's home when he walked across a wooden cover to an 8x8-foot, 26-foot deep well. Evan had seen grownups stand on the cover and had no reason to suspect that one of the boards was weak. As he crossed the well cover a board broke dropping him 21 feet into the well. Evan could not touch the bottom of the well but was able to tread water and stay afloat while his four year old cousin, Lucas Kirsch alerted Evan's aunt who immediately called Port Ludlow Rescue.

Evan continued to swim for about fifteen minutes while the firefighters were carefully removing the well cover so that it would not drop on him. Once the cover was off, they lowered two ropes and he was able to tie the ropes under his arms. Firefighters then pulled him out and rushed him to the hospital where he was found to have a number of abrasions and lacerations, but was otherwise in good condition.

Evan says he owes his life to his swimming lessons and his teacher and he also wants to thank the rescue team for their quick response in getting him out of the well. Evan was very calm and collected throughout the ordeal and his Dad is very proud of him.

## LMC Committees Keep Busy

A healthy exchange of ideas and information greeted the LMC Board of Trustees at its July 21, meeting. LMC members provided many helpful comments on agenda items and made suggestions to the Standing Committees.

A Public Hearing on the Port Ludlow Drainage District will be held on July 24 at 7:30 p.m. The Board voted to send a letter to the County Commissioners encouraging them to “listen to all LMC testimony with an open mind, objectively and without bias.” The Board will also openly make that statement at the hearing. The Board’s intent is to ensure that the Drainage District Board as well as LMC members are allowed to register their comments. Whatever the County decides will become law, effective 21 days after the Public Hearing.

### Committee Reports

**Greenbelt:** The Committee has designated four physical areas and assigned Committee members to each area. Additionally, the Committee has identified 11 concerns and these are being prioritized. If an LMC member has a complaint or request, please contact the Committee in writing. (Mail may be directed to the Committee c/o The Beach Club.)

**Finance:** A “Draft Reserve Policy” and “Reserve Fund Investment Policy” were presented to the Board for study and comment. Action will be taken at the August LMC meeting.

**Operations:** A lengthy discussion was held on the efficiency of swimming lessons vs. cost and disruption to the Beach Club. The Committee will be bringing a policy to the Board whereby any future swimming lessons will be contracted through the LMC, with preference for classes being given to LMC members. A request was made to also include specific hours for adult swimming. The Committee requests any complaints or concerns be sent to them in writing.

Larry Nobles asked the Board for funds to cover expenditures relating to proposed improvements/changes to the Beach Club. A total of up to \$3,000 was authorized for a basic structural study of the proposed Operations Committee plan; \$1,500 was approved for a feasibility study of column and clerestory removal of the current structure; and \$650 was approved for a structural study to expand to the west.

**Architectural Control:** Ten new homes are under construction; one lot clear and burn was disapproved. The Committee reminded LMC members that wire fences are not allowed in the North Bay. The Committee Chair asked for Board approval to instigate legal action against a home-owner who has refused to comply with CC&R’s. The Board approved the action.

**Covenants and Regulations:** Six proposed changes to the LMC governing policies were proposed to the Board. The areas covered include setting the minimum number of Architectural Control Committee (ACC) members and what would constitute a quorum; outdoor burning regulations, landlord requirements for leases and rental agreements, notification of adjacent property owners by both the ACC and Greenbelt Committees, and reestablishing adjacent lot-line setbacks, at the request of the ACC.

**Communications:** The Friday night TGIF get-together is still being held every Friday from 5:00 p.m. to 7:00 p.m. LMC members are encouraged to socialize with their neighbors, each family to bring their own drink and whatever food and utensils they need.

The next LMC Board meeting is scheduled for **August 18**, at the Beach Club.

## LOA News

At the July meeting of the LOA Board of Directors, Beach Club manager, Dick Smith, presented pool policy that had been adopted for this season. With the three summer sessions of swim lessons over, the LMC Operations Committee and Club Manager are formulating plans for the administration of lessons of all kinds offered at the Beach Club. In the future, all classes will be initiated by the Operations Committee, which will take requests from

LMC members. All courses will be operated and controlled by the LMC through the Operations Manager. All fees will be collected by the LMC, and instructors will be paid directly by the LMC. Class sizes will be limited and schedules will be approved by the Operations Committee. Preference will be given to LMC members before opening any classes to non-members. With reference to the swimming classes, the Operations Committee will try to provide better supervision of the locker rooms.

Questions were raised from the floor about current non-member use of the pools and the hours during prime summer months used for swim lessons, swim team and synchronized swimming. Insurance and liability were also questioned. A case was made for greater supervision of children in the locker rooms and for strict adherence to rules. Parents of swimmers expressed the importance of lessons for children and spoke to the changing face of the community. At this time, the number of North Bay lots/homeowners with children under 18 years of age has grown to about ten percent. Adult swimmers spoke to the need for more adult-only hours and stressed the importance of pool space for older adults to promote health and fitness. Lap swimmers were particularly concerned about having lap lanes available throughout the day in the outside pool.

The LOA Directors agreed to assist in distributing information and contacting voters concerning the September Special Election for Emergency Medical Service. Additional volunteer help would be appreciated. The various LOA committees would be glad to have volunteers. Anyone interested in helping to welcome newcomers, working with the Arts Committee, assisting with trails or Clean Sweep, please leave your name and interest in the LOA box in the Beach Club office.

There are no scheduled LOA Board meetings in August and September, but committee work is on-going. The Arts Committee has made significant progress in the piano search and is nearing a decision on a grand piano to be given to LMC for the Beach Club.

## South Bay Board Meeting Update

This report covers both the annual meeting held June 20 and the regular Board meeting held June 22. The major topic of the State of the Association message was the transition negotiations. It was emphasized that there were no legal binding documents or precedents to demand money from OPG. Rather the eight-month negotiations were conducted on the basis of obligations resulting from low SBCA reserves, funding of upgrades to the Bay Club that should have been made during the developer's tenure, etc.

Negotiations were completed and an agreement signed with the following results:

- \$55,000 was received and deposited to our reserve account to bring the account up to \$95,000 at year-end.
- After calendar year 2001, taxes on the Bay Club will be assessed to new lots as they are developed.
- \$9,000 was received and utilized for repair of building dry rot and swimming pool room insulation.

Outside of the agreement, the developer has also delivered the following funds:

- An additional \$5,000 was received during this fiscal year for reserve matching due in the last fiscal year.
- \$25,000 was received from the developer at the beginning of this fiscal year to give the Club operating funds.

The proposed budget for fiscal year 2001-2002 was presented for approval. Our budget shows Operating Revenue Receipts of \$303,452 and expenditures of \$297,262 for a projected cash surplus of \$6,190. The projection for the reserve account is that it will only increase to \$98,000 at the end of next fiscal year due to some anticipated expenditures. Operating fund carry over to the 2001-2002 fiscal year is forecast to be \$25,000. A motion was passed

to accept the new budget. For those of you with copies of the budget, there was a computer program error in the Payroll Expense Sub Total, which has since, been corrected. This error does not effect the budget details or totals.

In addition to a more user-friendly financial format, the long-range maintenance plan and five-year operating forecast are in place and the latter two will need to be updated each year. Also, beginning July 2001, organizations that do not consist solely of South Bay members will be charged for after-hour overtime of Bay Club employees at the rate of \$15 per hour.

The Board recommended that a formal audit, costing \$4000, be waived this year and this was so moved and passed by over a two-thirds majority. There was a general consensus that an audit by a creditable outside firm should be budgeted for some time in the next two to three fiscal years.

Barclay Hampton then presented information on proposed changes in the Architectural Review Committee (ARC) project approval process. The proposal is to pass down more of the routine decisions to each individual Village's ARC. However, in order to accomplish this, the support and cooperation of each Village is required.

Two amendments to the by-laws changing the principal office address of the SBCA and terms of office of the Directors were passed with little discussion. On the other hand, the proposed landscaping changes to the Master Declaration generated a lengthy discussion. Even though the purpose of the changes was to ease current restrictions, many homeowners felt the proposal still fell short of satisfying their needs. A motion was made and passed to table this change for more study. The new Board and ARC will have to pursue wording that is more acceptable to the general community.

Some of the other items discussed were:

- An objection to the use of member funds to provide alcohol at the monthly cocktail parties. This subject was slated to be discussed at the July Board meeting.
- It was brought up that there should be more notice given for nomination of new Board of Director candidates. It was agreed that the notification process should start in March.
- There was great difficulty in achieving a quorum for this meeting. The final count was 202 owners present in person or by proxy with a quorum requirement of 194. As the community gets larger, achieving a quorum may be even more difficult and the intention is to change the by-laws to the Washington State requirement of one-third of the members to establish a quorum.
- The homeowners in violation of the CC&Rs regarding playground equipment have submitted a proposal to the ARC which is being reviewed.
- Solutions to the humidity problem in the swimming pool room are being evaluated.
- Trail maintenance needs to be coordinated with the PLVC.

The new Board elected at the annual meeting consists of: Tony Durham, Tom Murray, Bill Schoenemann and Bob Wilkinson elected for two-year terms and Bert Goldstein, Bev Rothenborg and Chris Whitehurst who were elected for one-year terms. We urge you to contact these individuals as well as presenting your views at the monthly meetings held on the fourth Friday of each month. The next meeting will be **Friday, August 24**, 9:00 a.m. at the Bay Club.

## New Street Signs

Have you noticed the new street signs in Inner Harbor and Hidden Cove? Douglas Barber, Director of Maintenance on the Inner Harbor HOA Board, concluded last December that the street signs were rapidly becoming beyond repair. Using the Internet, he located a sign manufacturer in Erie, Pennsylvania and submitted a proposal to replace the signs for both Inner Harbor and Hidden Cove. Doug proceeded to obtain approval from Inner Harbor, Hidden Cove, SBCA and the ARC and ordered the new signs.

A local credible witness observed both Doug and Mari-  
anne Barber assisting with the installation of the new signs. The “Inner Harbor” entry sign will be repainted

to match the blue color of the street signs. According to Dorothy and Sterling Miller of Inner Harbor who submitted this article, “This project shows what local residents can do to enhance the appearance of the Village.”

## Season Tickets for 2001- 2002 Concert Season Now Available

**Arts Council Celebrates its Tenth Anniversary Season**

The Port Ludlow Arts Council celebrates its tenth anniversary season with a wide variety of concerts featuring a roster of entertainers from stages around the world, British Columbia, Seattle, the San Francisco Bay area and eastern Washington. According to vice president and program committee chair Beverly Rothenborg, "The 2001-2002 season will include Broadway, Celtic, classical, country and French bistro music as well as gospel, jazz, opera, pops plus a holiday choral concert of sacred and secular selections.

"This is our most ambitious season of the decade," said Patricia Anderson, out-going president. "As a newly-designated non-profit organization, we now can ask for contributions from businesses and residents. Since ticket sales and sponsor advertising don't completely cover our operating budget, we will be able to bring a higher caliber of entertainment to Port Ludlow with the help of contributors."

Performing Arts in Port Ludlow includes four evening Mainstage performances and three afternoon Matinee performances. The season opens with a gala evening Mainstage performance on **Friday, September 21**, featuring a return engagement by world-class soprano Cynthia Lawrence, and her husband, baritone Mark Calkins. ## More About Birding Than You Really Wanted to Know!

*This is one of a series by the Natural Resources Committee of the Port Ludlow Village Council, designed to inform Port Ludlow residents of the various processes and rewards of living environmentally-friendly lifestyles.*

What hobby boasts the largest number of participants worldwide? Port Ludlow folks might answer “boating, bridge, golf or tennis.” Wrong! It’s birding or birdwatching. Since publication of Roger Tory Peterson’s first book *Field Guide to the Birds*, in the 1930s, feeding, watching, listing, photographing, and even “chasing” birds has become the #1 hobby in the world. (“Chasing” is neither as wild nor as woolly as it sounds. It means hurrying off to any place a rare or unusual bird has been sighted out of its normal range. To experience this, call the Washington Bird Box at 206-281-9172 sponsored by the Washington Ornithological Society.)

### **It’s Easy to Start as a Birdwatcher. Consider these Options:**

Put out bird feeders and bird baths in your yard. (See Shari Hagey’s more general article in the April, 2000 *Voice*.) Good local sources for seed are Cenex in Port Hadlock and Wild Birds Unlimited in Gig Harbor. Hardware, grocery and other stores all sell inexpensive mixed seed labeled “Wild Bird Food.” However, it usually contains waste seed as filler. This is commonly rejected by the birds and may cause abundant weed growth. Feeders, birdbaths, and water drippers (to attract by sight and sound), winter suet holders, and birdhouses are all widely available.

Design and plant your property with bird habitat in mind. Birds like a combination of thickets and open glades. Put up appropriate bird housing, but be warned—birdhouses are not often used by many species in our short summer here.

Buy some of the plethora of bird information and identification books. In addition to the Peterson birding series (many volumes now), try National Geographic, Audubon or Stokes guides. Most recent is the encyclopedic *The Sibley Guide to the Birds* published by the National Audubon Society.

Get a good pair of binoculars with close-up focus: 7x35 or 8x40.

Join a local group: Admiralty Audubon Society, [jowarm@olympen.com](mailto:jowarm@olympen.com), Olympus Peninsula Audubon Society, <http://www.olympus.net/community/opas/>, Seattle Audubon Society, [www.seattleaudubon.org](http://www.seattleaudubon.org), National Audubon Washington State Office, <http://wa.audubon.org>.

Buy some of the many videos, tapes and CDs now flooding the market and subscribe to *Birdwatcher’s Digest* or *Birder’s World Magazine*.

Take classes or workshops offered at WSU Extension or Peninsula College or the Audubon groups listed above. Look for courses for beginners, or for specialty birding such as shorebirds, gulls or hawks.

Have your property certified as a Wildlife Preserve through the National Audubon program: National Audubon Society, 800-1274-4201 or 212-979-3000, [www.audubon.org](http://www.audubon.org). Membership in Audubon includes the excellent environmental *Audubon* magazine.

Attend a Birding Festival. Over 100 are offered yearly throughout the USA. Nearby festivals include the yearly Grays Harbor Shorebird Festival and the Othello Crane Festival. Information on these is available from each Chamber of Commerce.

Join other serious birders on a specialized birding tour such as Vent Tours *Winter Washington and British Columbia* (in February from Seattle). Call 800-328-8368 or [info@ventbird.com](mailto:info@ventbird.com).

And especially go outdoors into good birding habitat. The Olympic Peninsula has an excellent wide range of habitat from ocean to seashore to forest to mountains. Favorite spots locally: Lower Hadlock, Anderson Lake, Oak Bay County Parks, Seven Sisters Road, Bywater Bay State Park and Shine. The Port Townsend area has Kai Tai Lagoon, Fort Worden, North Beach and Chinese Gardens. Wintering waterfowl can be readily seen from the ferry to Keystone. Other good, but more distant, spots are Fort Flagler and Mystery Bay on Marrowstone Island, Sequim Bay, the shoreline at 3 Crabs Restaurant, Dungeness Spit, Ediz Hook (Port Angeles) and Olympic National Park.

The Port Townsend Marine Science Center offers seasonal boat trips to Protection Island to see such specialties as the Tufted Puffin and Rhinoceros Auklet.

## Dock Talk

On July 12, the Marina staff worked diligently with the Port Ludlow Fire Department on potential emergencies that could occur within the Marina. The drills involved man-overboard procedures, vessel on fire, oil spills, and vessels taking on water. The Marina staff has three codes identifying emergency situations. Code red, which identifies a fire; code blue, which identifies a medical emergency; and code yellow, which identifies any other emergency that is not a red or blue.

The drills began with a code red being called on the radio. Jordan, our store attendant, made a mock phone call to 911 and the dock attendants went into "vessel on fire" mode. We pulled the water pumps and began priming the pumps, and had our workboat dispatched to the outermost docks beyond the fire to pick up people and shuttle them to the beach. The Fire Department arrived within four minutes and took over control of the water pumps. We moved on to "man-overboard" procedures and practiced throwing a life ring. We had an imitation oil spill using dye tablets and contained the spill with our 50-foot oil boom. We completed the morning with the "vessel taking on water" drill. I timed this drill and it took less than five minutes to have our bilge pump and water pumps set up and ready to begin pumping out the vessel.

You can never be too prepared when an emergency arises. I would personally like to thank the Port Ludlow Fire Department for their help in organizing this emergency training day.

We said the *Voice* could not recommend the service and knew of no one who had tried it. Subsequently, we have heard from a friend of Boni Parker who writes from California: "Boni sent me a copy of your note regarding purchasing drugs from Ontario, Canada. I called the number listed and they sent me their instructions. I had my doctor write a six-month prescription plus a simple letter. I also wrote a letter as instructed and sent everything to Canada via International Priority mail. When they received my package, I received a call requesting my credit card number. The pills arrived and I am saving 32 cents per pill. It was a simple and speedy transaction."



## High-Speed Internet Access Comes to Port Ludlow

After writing about the forthcoming high-speed internet access offering from Millennium Digital Media (MDM) on a few occasions in the past year, I can now report that it is here and delivering what was promised. I had the luck to be one of the first Port Ludlow residents to sign on and have the CableSpeed product installed on my computer at home. My initial impression is very favorable. The days of slow screen painting and eternal downloads/uploads is a thing of the past for me and those of you choosing to sign up for the service. I believe the value is a good one for those who use the internet a lot. If you have a second phone line in your home to support a dialup modem and an ISP, the monthly costs are essentially the same for the high-speed offering. The lower speed offering (128K or 3-5 times the speed of a typical dialup modem) is also a good value.

So far, MDM's technical support for CableSpeed has been quite responsive and helpful. There are a number of things you need to be aware of before making your decision to sign up for CableSpeed:

- CableSpeed is a standalone service and not part of a given package; you do not need to subscribe to any of the TV offerings to get CableSpeed.
- Installation costs vary depending on factors such as location of your computer to the nearest cable connection in your house and the suitability of that cable (assuming you have any), and whether you have a network card in your computer or will settle for a USB device to which the cable modem is connected.
- Cable Modems are available for \$5 per month rental from MDM. This is actually the best approach as cable modems are very pricey now and the rental cable modem will be replaced at no cost to you if there are any problems with it.
- You do not need an ISP. There is no home page for CableSpeed, and as a result you are not bombarded with advertising about other MDM offerings. You can set up your home page to be anything you like.
- You get one free e-mail account with CableSpeed; additional e-mail accounts cost extra.
- MDM provides no capability to set up your own web page(s). There are websites available that let you set up your own web page(s) for no or a nominal cost.
- There is no capability to check your e-mail remotely. There are a number of free e-mail services available to fill that need; e.g., Hotmail.
- Although the installers seem quite competent, they may neglect to tell you about some of the obscure settings needed on your computer. The Computer Club (PLCC) will shortly publish a checklist of things that need to be done.
- The installers may or may not tell you about the need for a firewall—software or hardware that prevents your computer from being accessed over the internet by someone bent on mischief or to steal information. The PLCC strongly recommends the use of a firewall; some recommendations will be provided shortly.






